2. 2024/2025 Meeting Dates

Dates of Council and Working Group meetings for the next year had been circulated to Councillors prior to the meeting. All dates were approved. Proposed by Ian Woodroofe and seconded by Jim Perry.

3. Update 20 mile per hour scheme

The meeting closed at 8.11 pm.

Paul Webb gave an update on the work currently being carried out for the 20 mile per hour scheme. He informed the Council that a meeting via Zoom had been held with Highways. Concerns regarding the scheme were raised and Highways agreed to prepare some revised maps. Unfortunately, when received, the maps did not totally reflect the changes requested. Highways are now addressing the errors. An update statement was published on the Burwell Community Facebook page. A webpage with information about the 20 mile per hour scheme is being drafted for the Parish Council website. This will hopefully be ready to go live next week. The webpage will need to be updated as the scheme progresses. A Facebook Page will also be set up, separate from the main Parish Council page. The Safety Campaign email address will be used for correspondence. Sessions have been arranged where members of the public can view the maps. The dates of these sessions may need to change if receipt of the plans is delayed. Councillors were asked to sign up to cover the sessions. Draft maps, which do not include all the up-to-date details, are currently up on the wall at the Jubilee Reading Room. Councillors can look at these maps but may wish to wait until the correct maps are available. Should a member of the public see the maps if they visit the office, the Clerk will explain that they are not the final designs. Michael Geary asked if a Councillors' own view can be shared with members of the public when covering the sessions. It was agreed that own views can be shared as long it is made clear that it is the Councillors own view and as long as the Council's view is also given as a balance. Between two and three schemes will eventually be available for parishioners to consider. Lea Dodds said that it may be confusing having more than one proposal for members of the public to consider. Geraldine Tate raised concern that there is a need for the zoned option and without the zoned option, we may be in danger of getting a rejection of one proposal. Forms will be available at the sessions for comments.
