- LHI application window and drop-in session funding window open until 10th January 2025
 LHI application window for the 2025 / 2026 funding round has now reopened. The window will remain open until Friday 10th January at 17:00PM. Paul Webb has confirmed we are submitting an application. Several members of the Council are attending the Highways online drop-in session about how to apply
- 2. Newham Lane Temporary Prohibition of Through Traffic Order 2024-1652
- 3. Capitally funded Highway Maintenance Schemes submissions required by 8th December 2024 This request is for larger scale capital investment, which may include the following:
 - I. Major resurfacing or reconstruction of a significant length of road or footway/cycleway.
 - II. Installation of a new drainage system or replacement of a failed existing highway drainage system where there is severe flooding on the road.
 - III. Major maintenance of a Public Right of Way which may be unpassable or difficult to use.

The Council agreed that the Parish Clerk should submit applications for:

- i) Replacement of Toyse Lane surface currently cracking in very large areas/lengths. Also hope to mitigate residents' concerns around noise/excessive HGV usage though a quieter tarmac surface.
- ii) The Causeway pavement through to Hall Lane needs replacing. It is the busiest pedestrian thoroughfare in the village and is also a cycle path. Several people have had falls.
- iii) Improving the highway drainage between Gardiner Memorial Hall and the Church.

This was proposed by Jim Perry, seconded by Ian Woodroofe and agreed by all.
