- 1. District Report 11th March, 2025 Lavinia Edwards Report noted.
- 2. Energy Sub-Group meeting minutes 03.03.2025 Lea Dodds explained that the main priority for the group is the Mandeville Hall Energy Audit to ensure that the £25,000 grant is used in the best way. There is lack on knowledge overall on the heating system at the Gardiner Memorial Hall. How it operates requires more investigation. The energy unit for the Gardiner Memorial Hall has arrived and Richard Jenkins will get this fitted as soon as he is able to. Ken McCarthy

explained that there is a Mitsubishi App which can be used to access data from the Air Source Heat Pump. It is understood that this information can also be sourced directly from the machine. It has been noted that it is the same pump that is causing the P8 fault notification as previous. The Clerk is making progress with applying for the feed in tariff for the Gardiner Memorial Hall. Liz Swift thanked the group members for the work carried out.

The meeting closed at 7.55 pm.
