Highways Act 1980 – Section 119 The Cambridgeshire County Council (Lode Public Footpaths No. 7 (part) and No. 9 (part)) **Public Path Diversion Order 2020**

The above Order was made on the 22nd of July 2020 and was advertised for the statutory period of 4 weeks during which time objections were received. The case was referred to the Planning Inspectorate under the Secretary of State for Environment, Food and Rural Affairs who confirmed the order through a process of written representations. The decision has been included with this letter. The Secretary of State for Environment, Food and Rural Affairs confirmed the order on the 5th of March 2024, and we are now serving you with notice of this.

What happens next?

The effect of the Order as confirmed is to divert part of Lode Public Footpaths No. 7 and 9 in line with what is on the attached plan.

It is possible for anyone to question the validity of the order by making an application to the High Court within 6 weeks from the date of the publication of the confirmation. For a challenge to be successful, the person making the appeal would have to show that:

- The legislation was not applied correctly when confirming the Order; or
- The County Council has not followed the required legal procedures

On the 5th of March 2024 the Secretary of State for the Environment confirmed the above Order made under section 119 of the Highways Act 1980

The effect of the Order as confirmed is to divert Public Footpath No. 7, Lode starting at Ordnance Survey Grid Reference (OSGR) TL 5408 6491 (Point E on the Order map) and proceeds in a north-easterly direction for 100m at White Fen to a point at OSGR TL 5416 6498 (Point F) continuing in a north-westerly direction for 87m and then in a north-northeasterly direction for 111m crossing the Swaffham Bulbeck parish boundary to a junction with Swaffham Bulbeck Public Footpath No. 3 at OSGR TL 5412 6515 (Point H) to a new line starting at a point at OSGR TL 5408 6491 (Point E) and proceeding in a north-westerly direction for 11m to the north-western corner of White Fen at OSGR TL 5408 6492 (Point L), continuing in a north-easterly direction for 68m to the northern corner of White Fen at OSGR TL 5413 6496 (Point M). The path then proceeds northwards across an arable field for 88m to the southern corner of Norman's Pond at OSGR TL 5411 6505 (Point N), continuing in a north-westerly direction for 65m and then in a north-easterly direction for 87m to meet Swaffham Bulbeck Public Footpath No. 3 at OSGR TL 5412 6515 (Point H) and part of Public Footpath No.9 starting at Ordnance Survey Grid Reference (OSGR) TL 5417 6479 (Point J) and proceeds in a north-easterly direction for 9 metres to a point at OSGR TL 5418 6479 (Point K), continuing across to an open ditch and pond and through a woodland at White Fen in a northerly direction for 184 metres to a junction with Lode Public Footpath No.7 at OSGR TL 5416 6498 (Point F) to a new line starting at OSGR TL 5417 6479 (Point J) and proceeding in a north-westerly direction to the west of a drain for 150 metres to meet Lode Public Footpath No.7 at OSGR TL 5408 6491 (Point E) as shown on the Order Map.

The applicant has agreed to defray any expenses which are incurred in bringing the site of the new path into a fit condition for use by the public.
